We acknowledge receipt of your request for clarification of the information in the news article entitled "RLC Commercial REIT eyeing two infusions" posted in The Manila Times (Digital Edition) on May 25, 2026. The article reported that:

*"RL Commercial REIT Inc. (RCR), the real estate investment trust of Robinsons Land Corp. (RLC), is planning two asset infusions this year, with malls likely to comprise the next batch of properties to be injected into its portfolio.*

*At the same briefing, Kerwin Max Tan, chief financial officer, and risk and compliance officer at RCR, said the company and its fund manager had already identified a list of assets for infusion.*

*'We'll probably do the infusions in tranches,' Tan said, adding that the transactions would depend on market conditions.*

*He said they would 'try to do two tranches this year,' with an announcement likely in the next three months xxx"*

We confirm that RL Commercial REIT, Inc. (the "Company") is currently evaluating possible assets for infusion into the Company. We wish to clarify that any such infusion shall be undertaken in the normal course of business, subject to the evaluation of the Fund Manager of the Company and the approval of the Board of Directors and applicable Board committees, and shall remain subject to market conditions and other relevant considerations.


The Company will make the appropriate disclosures once the details have been finalized in accordance with applicable disclosure rules.
